• **LOW RATIO, HIGH CLEARANCE VEHICLES:** Suitable for all NZ Adventures Safaris. These vehicles are fitted with a transfer gearbox giving high and low ratios and also have high ground clearance and high profile tyres. This applies to most Utility style single cab extra and double cab 4WD vehicles. Examples might be Toyota Hilux, Mazda BT 50, Bounty. Ford Ranger, Couriers. Mitsubishi Triton.

THE SUITABLE: list would also include Nissan Safari, Patrol , Terrano , Navara D40 & D22. Mistral .Isuzu Bighorn, Mu & MUX. Honda Horizon & Crossroad. Holden Jackaroo, Monteray , Colorado 7 & Trailblazer. Mazda Marvie, Suzuki Vitara and Grand Vitara (later model standard Vitara are no longer suitable) Suzuki Jimny (2 persons only in Jimny) . Mitsubishi Pajero, Proceed ,Challengers & L300 Vans ,Toyota Surf, Prado Landcruisers, & Fortuna (all series including the same vehicles branded as Lexus) Landrover Defender, Jeep (any with Low range Transmission).and high_profile A/T Tyres only. Ford Explorer & Maverick, Hyundai Terracan,.The Nissan Navara D40s ,Ssangyong workmate and Suzuki Grand Vitara are great capable vehicles but a bit low and drivers need to be aware of this limitation.

UNSUITABLE: Vehicles would generally (there have been exceptions) include the following, Audi Q7,all Subaru , BMW X3,X5, & X9, VW Tiguan & Amarok Landrover Freelander, Discovery & Range Rover. Jeep Renegade, Mercedes, GL & M & ML Class, Ford Escape & Territory, Honda CRV, Nissan X Trail & Mirano & Pathfinder. Toyota Highlander, Harrier/Lexus RX ,Rav 4, Volvo XC, Holden Captiva, Mitrubishi Outlander, Airtrek, & RVR, SSangyong Kyron, Rexton,. Hyundai Sante Fe & Tuscon. Skoda Yeti, LDV, Great Wall, Foton.

This is an important document which may affect your legal rights and obligations. You must read the following acknowledgement, conditions and indemnity before you sign.

ACKNOWLEDGEMENT

Adventure activities and on/ off road four wheel driving can be hazardous.

1. Participating in this event exposes you to the risk of physical or mental injury and death.
2. Your vehicle, equipment or personal property may be lost, damaged or destroyed.
3. Other participants or members of the public may cause accidents or loss due to lack of care or skill.
4. Tracks, roads and structures you will be using are uncontrolled and are not maintained. Roads, tracks, trails and other ground will be in rough condition with defects hidden or exposed.
5. At no time do you have exclusive use of any track, road, trail, public land, or private property. Other users with and without vehicles, with or without permission of land managers, may be present at any time.
6. NZ Adventures, property owners, or managers, or any other ground or air operator will not be held responsible or liable for any loss, injury, or damage to property of any participant.
7. NZ Adventures reserve the right to alter the itinerary due to adverse weather or other operational condition.
8. NZ Adventures reserve the right to refuse entry to any persons, or to exclude from the event/tour, any entrants who may not, or do not comply with reasonable standards of behavior, or comply with the route instructions and may exclude from the course any vehicles which do not comply at all times with stated requirements.

BOOKINGS

1. Bookings may be limited and minimum numbers may be required to make up the tour.
2. A non-refundable booking fee of NZ \$300.00 per person, is required to reserve bookings.
3. Final payment is required no later than 90 days before departure.
4. There will be no refund for unused portions of the event.

CANCELLATION OR CURTAILMENT OF TOUR OR EVENT

1. In the circumstance of total abandonment of an event or tour after its commencement, through an extreme event of nature, or act of civil emergency, or force majeure, no refund will be paid.
2. In the circumstance of total abandonment of an event or tour within 7 days before its commencement, through an extreme event of nature, or act of civil emergency, or force majeure a refund of 80% of the final payment due excluding the non refundable deposit/Booking fee will be paid.
3. In the circumstance of total abandonment of an event or tour more than 7 days before its commencement, through an extreme event of nature, or act of civil emergency, or force majeure a refund of 90% of the final payment due excluding the non refundable deposit/ Booking Fee will be paid.

CANCELLATION BY CUSTOMER

If a customer wishes to cancel a booking for any reason (given that the full amount has been paid) the following cancellation policy will apply:

1. Up to 90 days before commencement - Refund less \$300.00 pp booking fee.
2. From 14 Days before commencement to 90 days - 50% refund.
3. Inside 14 days before commencement - No refund

TRAVEL INSURANCE

We recommend you take out comprehensive travel insurance. Not for sickness or injury, but in case you have to cancel your tour.

INDEMNITY AND DISCLAIMER

Drivers and passengers, will be required to sign this indemnity and disclaimer:

2. That I accept that the roads, tracks and structures we are using will not be maintained and will have apparent and hidden dangers.
3. That I accept and that my skill or experience in these situations may be limited and that NZ Adventures can not be liable for my lack of skill or judgment in these situations.
4. That I accept the skill or experience of others on the event or tour may be limited and that NZ Adventures will not be liable for their lack of skill or judgment in these situations.
5. That I accept that the vehicle I drive may have inherent or hidden faults or deficiencies for which NZ Adventures will not be liable.
6. That I indemnify and hold harmless, NZ Adventures, NZ Adventures sponsors, contractors, landowners, their respective servants, agents, or officials, against any actions or claims which may be made by me or on my behalf or by other parties for in respect of or arising out of my death or any injury, loss or damage caused by negligence, breach of contract or any other manner whatsoever.
